Evidence of Oil in the Ultra-deep Waters of the Santos Basin

(Rio de Janeiro, August 30, 2005). - PETRÓLEO BRASILEIRO S/A - PETROBRAS, [Bovespa: PETR3/PETR4, NYSE: PBR/PBRA, Latibex: XPBR/XPBRA], a Brazilian international energy company, announces that the c onsortium BM-S-10, made up of Petrobras (65%), BG (25%) and Partex (10%) is drilling the first exploratory well in the ultra-deep waters of the Santos Basin, in an area informally known as a "cluster".

In accordance with the current rules, Petrobras, as the operating company, has already notified this disclosure to the National Petroleum Agency.

When dealing with a new exploratory territory, the preliminary results are very important. Consequently, additional investments will be applied to evaluate the evidence of hydrocarbons.
