- (1) Includes 6.981 shares of common stock acquired through the reinvestment of dividends on January 3, 2008, at a price of of \$35.1901 per share.
- (2) Includes shares for restricted stock grants: 22,500 vest on 1/3/2010, 4,500 vest on 11/1/2009 and 4, 500 vest on 11/1/2011.
- (3) The number of underlying securities is based on the stock fund balance on January 3, 2008. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a January 3, 2008, stock fund price of \$35.02 per share.
- (4) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. Shares of phantom stock are payable in cash following the reporting person's termination of employment with the company and may be transferred by the reporting person into an alternative investment account at any time.
- (5) The phantom stock units were accrued under the Johnson Controls Equalization 401(k) Benefit Plan and are to be settled 100% in cash upon the reporting person's retirement or other termination of service with the company.
- (6) Includes 4.479 phantom stock units acquired through reinvestment of dividends on January 3, 2008, at a price of of \$35.02 per phantom unit.
- (7) The phantom stock units were accrued under the Johnson Controls Annual Incentive Compensation Plan and are to be settled 100% in cash upon the reporting person's retirement or other termination of service with the company.
- (8) Includes 44.497 phantom stock units acquired through reinvestment of dividends on January 3, 2008, at a price of of \$35.02 per phantom unit.
- (9) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock Grant.
- (10) Includes 263.417 phantom stock units acquired through reinvestment of dividends on January 3, 2008, at a price of of \$35.02 per phantom unit.
- (11) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
