On December 31, 2007, the Issuer acquired Haverstick Consulting, Inc., an Indiana corporation, of which the reporting person is President. Pursuant to the Agreement and Plan of Merger, the issuer issued to the reporting person 350,230 shares of common stock in exchange for shares of Haverstick Consulting, Inc. previously owned by the reporting person. The shares of issuer's common stock were valued at \$2.74/share based upon a 20 day average trailing stock price of issuer's common stock prior to the execution of the definitive Agreement and Plan of Merger on November 2, 2007.

(2) Each restricted stock unit represents a contingent right to receive one share of issuer's common stock.

The restricted stock units vest in four equal installments beginning December 31, 2008. Vested shares will be delivered to the reporting person on the first date which is administratively practicable for the distribution of the vested shares after termination of service with the issuer.
