(1) The exercise and sale of these stock options was completed pursuant to the Rule 10b5-1 trading plan adopted by Jonathan H. Corr.

The price reported is a weighted average price. The shares were sold in multiple transactions ranging from \$54.795 to \$55.565, inclusive.

An additional 25% of the total shares awarded will vest on each of March 20, 2015, March 20, 2016, and March 20, 2017, subject to continuous service through such dates.
