As calculated in accordance with Rule 13d-3 of the Securities Exchange Act of 1934, as amended, (i) Sabby Volatility Warrant Master Fund, Ltd. beneficially owns 1,648,609 shares of the Issuer's common stock (Common Stock), representing approximately 7.55% of the Common Stock, and (ii) Sabby Management, LLC and Hal Mintz each beneficially own 2,115,873 shares of the Common Stock, representing approximately 9.68% of the Common Stock. Sabby Management, LLC and Hal Mintz do not directly own any shares of Common Stock, but each indirectly owns 2,115,873 shares of Common Stock. Sabby Management, LLC, a Delaware limited liability company, indirectly owns 2,115,873 shares of Common Stock because it serves as the investment manager of Sabby Volatility Warrant Master Fund, Ltd. and Sabby Healthcare Master Fund, Ltd. Mr. Mintz indirectly owns 2,115,873 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
