Subject to the terms of the Second Amended and Restated Limited Liability Company Agreement of Parsley Energy, LLC, by and among Parsley Energy, LLC and the members thereof, the Parsley Energy, LLC Membership Units (together with a corresponding number of shares of Class B common stock) are exchangeable from time to time for shares of Class A common stock of Parsley Energy, Inc.
