On November 30, 2017, Mr. Charles W. Ergen established a Grantor Retained Annuity Trust ("GRAT"), the Ergen Two-Year 2017 DISH GRAT (the "Two-Year 2017 GRAT") and contributed 40,000,000 Class B shares to the Two-Year 2017 GRAT. The Two-Year 2017

(1) GRAT may elect to convert any or all of its Class B shares into an equal number of Class A shares at any time for no additional consideration. The Two-Year 2017 GRAT is scheduled to expire in accordance with its terms on November 30, 2019. Mrs. Cantey M. Ergen serves as the trustee of such GRAT.

(2) Pursuant to the terms of the Two-Year 2017 GRAT, 29,196,663 Class B shares were distributed as an annuity to Mr. Ergen on November 30, 2018. Following this distribution, the Two-Year 2017 GRAT retained 10,803,337 Class B shares.
