## Entry into a Material Definitive Agreement

On February 6, 2013, Eastman Kodak Company (the “Company”), Kodak Canada Inc. (together, the “Borrowers”), certain subsidiaries of the Company and certain lenders and agents under the Borrowers’ Debtor-in-Possession Credit Agreement, dated as of January 20, 2012 (as amended, supplemented or otherwise modified) (the “Credit Agreement”), entered into an amendment to the Credit Agreement (the “Amendment”), which extended the date by which the Company was required to file a plan of reorganization and an accompanying disclosure statement with the U.S. Bankruptcy Court for the Southern District of New York (the “Bankruptcy Court”) from February 15, 2013 to April 30, 2013. The Company sought the Amendment to provide the Company with time to optimize its initial plan of reorganization before filing it with the Bankruptcy Court. The Amendment became effective on February 6, 2013.
