On July 30, 2013, Eastman Kodak Company, on behalf of itself and its debtor affiliates, filed the Plan Supplement to its Joint Plan of Reorganization (the “Plan”) with the United States Bankruptcy Court for the Southern District of New York (the “Bankruptcy Court”). The Plan, including the Plan Supplement, is subject to confirmation by the Bankruptcy Court, and will be considered at a hearing scheduled before the Bankruptcy Court on August 20, 2013. A copy of the press release related to the filing of the Plan Supplement is attached as an exhibit hereto.

The Plan Supplement shall not be deemed “filed” for purposes of Section 18 of the Securities Exchange Act of 1934, as amended, is not otherwise subject to the liabilities of that section, and is not deemed incorporated by reference in any filing under the Securities Act of 1933, as amended, except as shall be expressly set forth by specific reference in such a filing. The Plan Supplement is subject to material change and may not contain information suitable for making an investment decision about the current outstanding securities of Eastman Kodak Company.
