(1) This amended form 4 is being filed to correctly reflect the reporting person's direct ownership shares of SEI Investments Company ("SEI") common stock, which ownership was over-reported due to an inadvertent mathematical error by 30,090 shares. The reporting person's direct ownership of shares of SEI following the transactions reported on the original form 4 should have been reported as 17,862,186 shares, instead of 17,892,276.

(2) The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$23.25 to \$23.55, inclusive. The reporting person undertakes to provide to SEI, any security holder of SEI, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the ranges set forth in footnote (2) of this form 4.
