(d) On July 17, 2018, the Board of Directors (the "Board") of Skyworks Solutions, Inc. (the "Registrant"), increased the size of the Board from nine to ten and appointed Kimberly S. Stevenson as a new director of the Registrant, upon the recommendation of its Nominating and Corporate Governance Committee. Ms. Stevenson will serve until the Registrant's 2019 annual meeting of stockholders, when she will be a nominee for election to the Board by a vote of the Registrant's stockholders, and thereafter until her successor has been duly elected and qualified. The Board has not yet determined Ms. Stevenson's committee assignments. Ms. Stevenson's cash compensation will be as set forth in the Registrant's Cash Compensation Plan for Directors, which was filed with the Securities and Exchange Commission (the "SEC") on July 20, 2018, as Exhibit 10.1 to the Registrant's Quarterly Report on Form 10-Q. Ms. Stevenson will also be eligible to receive equity awards under the Registrant's Amended and Restated 2008 Director Long-Term Incentive Plan, as Amended, which was filed with the SEC on May 4, 2018, as Exhibit 10.1 to the Registrant's Quarterly Report on Form 10-Q, including an initial award of restricted stock units as provided for therein.
