REMARKS: (1)

The 240,000 shares disclosed in Item 3 on Page 1 and in Table II are the subject of Section 10b5-1 Trading Plans ("Plans"). The Reporting Person through one of the brokers will sell up to 80,000 shares per month. The brokers will alternate months with Merrill Lynch , Pierce, Fenner & Smith which began in March 2002, and UBSPaineWebber Inc. which began in April 2002. The 240,000 shares are the maximum number of shares to be sold during a three month period. The Plans are scheduled to terminate no later than February 28, 2003 subject to earlier termination per the provisions as set out in the Plans.
