- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 2,903 units were acquired at prices ranging from \$39.06 to \$48.76. These transactions are exempt under rule 16a-11 and rule 16a-3(f).
- (2) Each phantom unit is the economic equivalent of one limited partner unit in Cedar Fair, L.P.
- (3) This award vests in two equal installments on March 4, 2013 and 2014, respectively, assuming the grantee continues to be employed with the Company.
- (4) This award vests in two equal installments on March 3, 2014 and 2015, respectively, assuming the grantee continues to be employed with the Company.
- (5) Options vest at a rate of 33% per year on each anniversary date, beginning on February 26, 2014.
- (6) Options vest at a rate of 33% per year on each anniversary date, beginning on March 27, 2013.
