Distributions by Sage Summit LP and Lavender Heights Capital LP (the "Partnerships") of 1,999,077 shares and 1,332,719 shares of common stock of GLG Partners, Inc. ("GLG"), respectively, to certain of their respective limited partners upon the satisfaction of certain vesting conditions under the partnership agreements of the Partnerships. The shares of GLG common stock were received by the Partnerships as part of the consideration paid for the acquisition by GLG (formerly named Freedom Acquisition Holdings, Inc.) of equity interests in GLG Partners LP and its affiliated entities.

(1) These shares are owned solely by Sage Summit LP (and its general partner Sage Summit Limited, and Mount Granite Limited, the managing member of Sage Summit Limited), which may be deemed a member of a "group" with Lavender Heights Capital LP (and its general partner, Mount Garnet Limited), Noam Gottesman, Leslie J. Schreyer, in his capacity as trustee of the Gottesman GLG Trust, Emmanuel Roman, Jeffrey A. Robins, in his capacity as trustee of the Roman GLG Trust, Pierre Lagrange, G&S Trustees Limited, in its capacity as trustee of the Lagrange GLG Trust, Jackson Holding Services Inc. and Point Pleasant Ventures Ltd. (the "13D Group") for purposes of Section 13(d) of the Securities Exchange Act of 1934, as amended, by virtue of their being parties to the Voting Agreement dated June 22, 2007, as amended (the "Voting Agreement"), among the members of the 13D Group.

(2) These shares are owned solely by Sage Summit LP (and its general partner Sage Summit Limited, and Mount Granite Limited), which may be deemed a member of the 13D Group for purposes of Section 13(d) by virtue of being a party to the Voting Agreement.

(3) Each of Sage Summit LP and Lavender Heights Capital LP disclaims beneficial ownership of the securities held by each other member of the 13D Group.
