Item 1(a). NAME OF ISSUER

The name of the issuer is Forest Oil Corporation (the "Company").

Item 1(b). ADDRESS OF ISSUER'S PRINCIPAL EXECUTIVE OFFICES

- (iv) Saba Capital Management, L.P., a Delaware limited partner ("Saba Capital") as investment manager of SCMF, SCMF II and SCLMF, with respect to the shares of Common Stock held by SCMF, SCMF II and SCLMF; and
- (v) Boaz R. Weinstein ("Mr. Weinstein"), member of Saba Capital Management GP, LLC, the general partner of Saba Capital, with respect to the shares of Common Stock held by SCMF, SCMF II and SCLMF.
