Work will be done under ITSS-3, a multiple-agency, indefinite delivery indefinite quantity (IDIQ) contract, through competitively awarded task orders potentially worth US\$980 million over the duration of the seven-year contract. Task orders can range from support pertaining to information security, systems design, data warehousing and records management.
