**Item 1.01 Entry into a Material Definitive Agreement.**

On January 13, 2009, Lifetime Brands, Inc. (the "Company") entered into Amendment No. 3 to the Shares Subscription Agreement by and among Lifetime Brands, Inc., Grupo Vasconia S.A.B ("Vasconia") (formerly know as Ekco, S.A.B.) and Mr. José Ramón Elizondo Anaya and Mr. Miguel Ángel Huerta Pando, dated as of June 8, 2007. The terms of the amendment are effective December 30, 2008.

The amendment extends the date through which the Company has the right to require Vasconia to repurchase the Company's ownership interest in Vasconia to March 31, 2009.
