The delay is principally because of the Registrant's Chapter 11 Bankruptcy filing and substantial management focus on reorganization efforts resulting in reduced company resources. Due to the lack of personnel of the Registrant to compile financial information for the audit, BDO Seidman, LLP, the independent auditors of the Registrant, has not yet completed the audit of the financial statements of the Registrant for the year ended December 31, 2000 and cannot furnish the required opinion on such financial statements until it has completed its audit.
