Of the 23,636,502 Shares deemed to be beneficially owned by the Fund, 23,136,502 are owned by the Fairholme Fund and 500,000 are owned by The Fairholme Allocation Fund, each a series of the Fund.

Fairholme has the sole power to vote or direct the vote of 0 Shares, the Fund has the sole power to vote or direct the vote of 0 Shares and Bruce R. Berkowitz has the sole power to vote or direct the vote of 0 Shares to which this filing relates.
