DTE Energy Company (“DTE Energy”) will meet with investors on November 18-19, 2013. In the meetings and the presentation, DTE Energy reaffirms its 2013 operating earnings per share guidance of \$3.95-\$4.15 per share and its 2014 early outlook operating earnings guidance range of \$4.15-\$4.39 per share.

In its business presentation and this filing, DTE Energy discusses 2013 and 2014 operating earnings guidance. It is likely that certain items that impact the company's 2013 and 2014 reported results will be excluded from operating results. Reconciliations to the comparable 2013 and 2014 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
