CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 3,825,010 shares or 6.6% of the 58,369,000 shares of Common Stock believed to be outstanding.
