The securities offered by this pricing supplement are unsecured senior debt securities issued by Citigroup Global Markets Holdings Inc. and guaranteed by Citigroup Inc. Unlike conventional debt securities, the securities do not pay interest, do not guarantee the repayment of principal at maturity and are subject to potential automatic early redemption on an annual basis on the terms described below. Your return on the securities will depend on the **worst performing** of the EURO STOXX 50<sup>®</sup> Index and the shares of the iShares<sup>®</sup> MSCI EAFE ETF (each, an “underlying asset”).

The securities provide for the repayment of principal plus a premium following the first valuation date on which the closing value of the worst performing underlying asset is greater than or equal to the applicable premium threshold value. However, if the closing value of the worst performing underlying asset is not greater than or equal to the applicable premium threshold value on any of the valuation dates prior to the final valuation date, the securities will not be automatically redeemed at a premium and, instead, you will receive a payment at maturity that may be greater than, equal to or less than the stated principal amount, depending on the performance of the worst performing underlying asset from the pricing date to the final valuation date. **If the securities are not automatically redeemed prior to maturity and the closing value of the worst performing underlying asset on the final valuation date is less than 65% of its starting value, you will lose at least 35%, and possibly significantly more, of your investment in the securities.** Your return on the securities will depend solely on the performance of the worst performing underlying asset, and you will not benefit in any way from the performance of the better performing underlying asset.

If we and Citigroup Inc. default on our obligations, you may not receive any amount owed to you under the securities. **All payments on the securities are subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc.**

#### Additional Information

**General.** The terms of the securities are set forth in the accompanying product supplement, prospectus supplement and prospectus, as supplemented by this pricing supplement. The accompanying product supplement, prospectus supplement and prospectus contain important disclosures that are not repeated in this pricing supplement. For example, certain events may occur that could affect your payment at maturity. These events and their consequences are described in the accompanying product supplement in the sections “Description of the Securities—Certain Additional Terms for Securities Linked to an Underlying Index—Consequences of a Market Disruption Event; Postponement of a Valuation Date” and “—Discontinuance or Material Modification of an Underlying Index” or “—Certain Additional Terms for Securities Linked to ETF Shares or Company Shares—Consequences of a Market Disruption Event; Postponement of a Valuation Date,” “—Dilution and Reorganization Adjustments,” and “—Delisting, Liquidation or Termination of an Underlying ETF,” and not in this pricing supplement. The accompanying underlying supplement contains important disclosures regarding each underlying asset that are not repeated in this pricing supplement. It is important that you read the accompanying product supplement, underlying supplement, prospectus supplement and prospectus together with this pricing supplement before deciding whether to invest in the securities. **Relevant price.** With respect to the iShares<sup>®</sup> MSCI EAFE ETF, its starting value, its premium threshold value and its trigger value are each a “Relevant Price” for purposes of the section “Description of the Securities—Certain Additional Terms for Securities Linked to ETF Shares or Company Shares—Dilution and Reorganization Adjustments” in the accompanying product supplement. Accordingly, the starting value, the premium threshold value and the trigger value with respect to the iShares<sup>®</sup> MSCI EAFE ETF are each subject to adjustment upon the occurrence of any of the events described in that section.

**Postponement of a valuation date.** If any valuation date is not a scheduled trading day for either of the underlying assets or if a market disruption event occurs with respect to either of the underlying assets on any valuation date, that valuation date will be subject to postponement as described in the accompanying product supplement in the sections “Description of the Securities—Certain Additional Terms for Securities Linked to an Underlying Index—Consequences of a Market Disruption Event; Postponement of a Valuation Date” or “—Certain Additional Terms for Securities Linked to ETF Shares or Company Shares—Consequences of a Market Disruption Event; Postponement of a Valuation Date.” If any valuation date is postponed, the closing value of each of the underlying assets in respect of that valuation date will be determined based on (i) for any underlying asset for which the originally scheduled valuation date is a scheduled trading day and as to which a market disruption event does not occur on the originally scheduled valuation date, the closing value of such underlying asset on the originally scheduled valuation date and (ii) for any other underlying asset, the closing value of such underlying asset on the valuation date as postponed (or, if earlier, the first scheduled trading day for such underlying asset following the originally scheduled valuation date on which a market disruption

event did not occur with respect to such underlying asset).

### Hypothetical Examples

The diagram below illustrates the payment you may receive upon automatic early redemption, if applicable, or at maturity of the securities, for a range of hypothetical percentage changes in the closing value of the worst performing underlying asset from the pricing date to the applicable valuation date. Your payment upon automatic early redemption, if applicable, or at maturity will be determined solely based on the performance of the worst performing underlying asset, regardless of the performance of the other underlying asset, on the applicable valuation date. The diagram and table below assumes that the premium applicable to each valuation date will be set at the minimum value indicated on the cover page of this pricing supplement.

**Investors in the securities will not receive any dividends that may be paid on the stocks that are included in or held by either underlying asset. The diagram and examples below do not show any effect of lost dividend yield over the term of the securities.** See “Summary Risk Factors—Investing in the securities is not equivalent to investing in either underlying asset or the stocks included in or held by either underlying asset” below.

The following table illustrates how the amount payable per security will be calculated if the closing value of the worst performing underlying asset is greater than or equal to the applicable premium threshold value on one of the five valuation dates. Figures below have been rounded for ease of analysis.

<b>If the first valuation date on which the closing value of the worst performing underlying asset is greater than or equal to the applicable premium threshold value is . . .</b>	<b>. . . then you will receive the following payment per security upon automatic early redemption or at maturity, as applicable:</b>
February 27, 2019	$\$1,000 + \text{applicable premium} = \$1,000 + \$142.50 = \$1,142.50$
February 27, 2020	$\$1,000 + \text{applicable premium} = \$1,000 + \$285.00 = \$1,285.00$
March 1, 2021	$\$1,000 + \text{applicable premium} = \$1,000 + \$427.50 = \$1,427.50$
February 28, 2022	$\$1,000 + \text{applicable premium} = \$1,000 + \$570.00 = \$1,570.00$
February 27, 2023	$\$1,000 + \text{applicable premium} = \$1,000 + \$712.50 = \$1,712.50$

**If, on any valuation date, the closing value of one underlying asset is greater than or equal to the applicable premium threshold value but the closing value of the other underlying asset is less than the applicable premium threshold value, you will not receive the premium indicated above following that valuation date. In order to receive the premium indicated above, the closing value of *both* underlying assets must be greater than the applicable premium threshold value on the applicable valuation date.**

The examples below illustrate how the payment at maturity will be calculated if the closing value of the worst performing underlying asset on any of the valuation dates is **not** greater than or equal to the applicable premium threshold value. The examples are based on (i) with reference to the EURO STOXX 50® Index, a hypothetical starting value of 3,400.00, a hypothetical premium threshold value of 3,400.00 and a hypothetical trigger value of 2,210.00 and (ii) with reference to the shares of the iShares® MSCI EAFE ETF, a hypothetical starting value of 70.00, a hypothetical premium threshold value of 70.00 and a hypothetical trigger value of 45.50 and the hypothetical closing values on the final valuation date indicated below. If the securities are not automatically redeemed prior to maturity, your actual payment at maturity will depend on the actual closing value of the worst performing underlying asset on the final valuation date.

**Example 1—Par Scenario.** On the final valuation date, the hypothetical closing value of the EURO STOXX 50® Index is 2,890.00 (a 15% decrease from its hypothetical starting value) and the hypothetical closing value of the shares of the iShares® MSCI EAFE ETF is \$73.50 (a 5% increase from its hypothetical starting value). The worst performing underlying asset is the underlying asset with the lowest underlying asset performance factor, which is calculated for each underlying asset as follows:



Underlying asset performance factor of the EURO STOXX 50<sup>®</sup> Index = closing value on final valuation date / starting value

$$=2,890.00 / 3,400.00$$
$$=0.85$$

Underlying asset performance factor of the shares of the iShares<sup>®</sup> MSCI EAFE ETF = closing value on final valuation date / starting value

$$= \$73.50 / \$70.00$$
$$= 1.05$$

Because the underlying asset performance factor of the EURO STOXX 50<sup>®</sup> Index is lower than the underlying asset performance factor of the shares of the iShares<sup>®</sup> MSCI EAFE ETF in this example, the EURO STOXX 50<sup>®</sup> Index would be the worst performing underlying asset. In this scenario, because the closing value of the worst performing underlying asset on the final valuation date is less than the applicable premium threshold value but greater than the applicable trigger value, you would be repaid the stated principal amount of \$1,000 per security at maturity but would not receive any premium.

**Example 2—Downside Scenario.** On the final valuation date, the hypothetical closing value of the EURO STOXX 50<sup>®</sup> Index is 2,550.00 (a 25% decrease from its hypothetical starting value) and the hypothetical closing value of the shares of the iShares<sup>®</sup> MSCI EAFE ETF is \$28.00 (a 60% decrease from its hypothetical starting value). The worst performing underlying asset is the underlying asset with the lowest underlying asset performance factor, which is calculated for each underlying asset as follows:

Underlying asset performance factor of the EURO STOXX 50<sup>®</sup> Index = closing value on final valuation date / starting value

$$=2,550.00 / 3,400.00$$

Because the underlying asset performance factor of the shares of the iShares<sup>®</sup> MSCI EAFE ETF is lower than the underlying asset performance factor of the EURO STOXX 50<sup>®</sup> Index in this example, the shares of the iShares<sup>®</sup> MSCI EAFE ETF would be the worst performing underlying asset. In this scenario, because the closing value of the worst performing underlying asset on the final valuation date is less than the applicable trigger value, the payment at maturity per security would be calculated as follows:

$$\begin{aligned} \text{Payment at maturity per security} &= \$1,000 \times \text{the underlying asset performance factor of the worst performing underlying asset on the final valuation date} \\ &= \$1,000 \times 0.40 \\ &= \$400 \end{aligned}$$

In this scenario, the worst performing underlying asset has depreciated by more than 35% from its starting value to its closing value on the final valuation date, which is less than the applicable trigger value. Accordingly, your payment at maturity in this scenario would reflect 1-to-1 downside exposure to the depreciation of the worst performing underlying asset from its starting value to its closing value on the final valuation date, and you would incur a significant loss on your investment.

#### Summary Risk Factors

An investment in the securities is significantly riskier than an investment in conventional debt securities. The securities are subject to all of the risks associated with an investment in our conventional debt securities (guaranteed by Citigroup Inc.), including the risk that we and Citigroup Inc. may default on our obligations under the securities, and are also subject to risks associated with both of the underlying assets. Accordingly, the securities are suitable only for investors who are capable of understanding the complexities and risks of the securities. You should consult your own financial, tax and legal advisors as to the risks of an investment in the securities and the suitability of the

securities in light of your particular circumstances.

The following is a summary of certain key risk factors for investors in the securities. You should read this summary together with the more detailed description of risks relating to an investment in the securities contained in the section “Risk Factors Relating to the Securities” beginning on page EA-6 in the accompanying product supplement. You should also carefully read the risk factors included in the accompanying prospectus supplement and in the documents incorporated by reference in the accompanying prospectus, including Citigroup Inc.’s most recent Annual Report on Form 10-K and any subsequent Quarterly Reports on Form 10-Q, which describe risks relating to the business of Citigroup Inc. more generally.

**You may lose some or all of your investment.** Unlike conventional debt securities, the securities do not guarantee repayment of the stated principal amount at maturity. If the securities are not automatically redeemed prior to maturity, your payment at maturity will depend on the performance of the worst performing underlying asset. If the closing value of the worst performing underlying asset on the final valuation date is less than the applicable trigger § value, you will lose 1% of the stated principal amount of the securities for every 1% by which the worst performing underlying asset has declined from its starting value, regardless of the performance of the other underlying asset. There is no minimum payment at maturity on the securities, and you may lose your entire investment in the securities.

**The trigger feature of the securities exposes you to particular risks.** If the closing value of the worst performing underlying asset on the final valuation date is less than the applicable trigger value, you will lose 1% of the stated principal amount of the securities for every 1% by which the worst performing underlying asset has declined from its § starting value. Although you will be repaid your stated principal amount at maturity if the worst performing underlying asset on the final valuation date depreciates by 35% or less from its starting value, you will have full downside exposure to the worst performing underlying asset on the final valuation date if it depreciates by more than 35%. As a result, you may lose your entire investment in the securities.

**The securities do not pay interest.** You should not invest in the securities if you seek current income during the § term of the securities.

**Your potential return on the securities in connection with an early redemption is limited.** If the securities are automatically redeemed, your potential return on the securities is limited to the applicable premium payable upon automatic early redemption, as described on the cover page of this pricing supplement. If the closing value of the worst performing underlying asset on one of the valuation dates is greater than or equal to the applicable premium § threshold value, you will be repaid the stated principal amount of your securities and will receive the fixed premium applicable to that valuation date, regardless of how significantly the closing value of the worst performing underlying asset on that valuation date may exceed the applicable premium threshold value. Accordingly, the premium may result in a return on the securities that is significantly less than the return you could have achieved on a direct investment in either or both of the underlying assets. In addition, the premium you receive upon any early redemption of the

securities may be significantly less than the return you could have achieved if the securities had not been automatically redeemed and you had been able to receive the payment at maturity.

**The securities are subject to the risks of both underlying assets and will be negatively affected if either underlying asset performs poorly, even if the other performs well.** You are subject to risks associated with each of the underlying assets. If either underlying asset performs poorly, you will be negatively affected, even if the other § underlying asset performs well. The securities are not linked to a basket composed of the underlying assets, where the better performance of one could ameliorate the poor performance of the other. Instead, you are subject to the full risks of whichever of the underlying assets is the worst performing underlying asset.

**You will not benefit in any way from the performance of the better performing underlying asset.** The return on the securities depends solely on the performance of the worst performing underlying asset, and you will not benefit in any way from the performance of the better performing underlying asset. The securities may underperform a § similar investment in each of the underlying assets or a similar alternative investment linked to a basket composed of the underlying assets, since in either such case the performance of the better performing underlying asset would be blended with the performance of the worst performing underlying asset, resulting in a better return than the return of the worst performing underlying asset.

**The term of the securities may be as short as one year.** If the closing value of the worst performing underlying § asset on any valuation date, including the valuation date expected to occur approximately one year after the pricing date, is greater than or equal to the applicable premium threshold value, the securities will be automatically redeemed. The earlier the automatic redemption, the lower the premium you will receive.

**You will be subject to risks relating to the relationship between the underlying assets.** It is preferable from your perspective for the underlying assets to be correlated with each other, in the sense that they tend to increase or decrease at similar times and by similar magnitudes. By investing in the securities, you assume the risk that the underlying assets will not exhibit this relationship. The less correlated the underlying assets, the more likely it is that one of the underlying assets will perform poorly over the term of the securities. All that is necessary for the § securities to perform poorly is for one of the underlying assets to perform poorly; the performance of the underlying asset that is not the worst performing underlying asset is not relevant to your return on the securities at maturity or on an earlier automatic redemption date. It is impossible to predict what the relationship between the underlying assets will be over the term of the securities. **The EURO STOXX 50® Index represents large capitalization stocks in the Eurozone and the iShares® MSCI EAFE ETF represents large and mid-capitalization developed market equities. Accordingly, the underlying assets represent markets that differ in significant ways and, therefore, may not be correlated with each other.**

§ **Investing in the securities is not equivalent to investing in either underlying asset or the securities included in or held by either underlying asset.** You will not have voting rights, rights to receive any dividends or other distributions or any other rights with respect to any of the securities included in or held by either underlying asset. It is important to understand that, for purposes of measuring the performance of

the underlying assets, the values used will not reflect the receipt or reinvestment of dividends or distributions on the securities included in or held by the underlying assets. Dividend or distribution yield on the securities included in or held by the underlying assets would be expected to represent a significant portion of the overall return on a direct investment in the securities included in or held by the underlying assets, but will not be reflected in the performance of the underlying assets as measured for purposes of the securities (except to the extent that dividends and distributions reduce the values of the underlying assets). “constructive ownership transaction,” with potentially adverse consequences described below under “United States Federal Tax Considerations.” In addition, in 2007 the U.S. Treasury Department and the IRS released a notice requesting comments on various issues regarding the U.S. federal income tax treatment of “prepaid forward contracts” and similar instruments. ## United States Federal Tax Considerations

You should read carefully the discussion under “United States Federal Tax Considerations” and “Risk Factors Relating to the Securities” in the accompanying product supplement and “Summary Risk Factors” in this pricing supplement.

In the opinion of our counsel, Davis Polk & Wardwell LLP, which is based on current market conditions, a security should be treated as a prepaid forward contract for U.S. federal income tax purposes. By purchasing a security, you agree (in the absence of an administrative determination or judicial ruling to the contrary) to this treatment. There is uncertainty regarding this treatment, and the IRS or a court might not agree with it.

Assuming this treatment of the securities is respected and subject to the discussion in “United States Federal Tax Considerations” in the accompanying product supplement, the following U.S. federal income tax consequences should result under current law:

You should not recognize taxable income over the term of the securities prior to maturity, other than pursuant to a sale or exchange.

Upon a sale or exchange of a security (including retirement at maturity), you should recognize gain or loss equal to the difference between the amount realized and your tax basis in the security. Subject to the discussion below concerning the potential application of the “constructive ownership” rules under Section 1260 of the Code, any gain or loss recognized upon a sale, exchange or retirement of a security should be long-term capital gain or loss if you held the security for more than one year.

Even if the treatment of the securities as prepaid forward contracts is respected, your purchase of a security may be treated as entry into a “constructive ownership transaction,” within the meaning of Section 1260 of the Code, with respect to the underlying ETF shares. In that case, all or a portion of any long-term capital gain you would otherwise recognize in respect of your securities would be recharacterized as ordinary income to the extent such gain exceeded the “net underlying long-term capital gain.” Any long-term capital gain recharacterized as ordinary income under Section 1260 would be treated as accruing at a constant rate over the period you held your securities, and you would be subject to an interest charge in respect of the deemed tax liability on the income treated as accruing in prior tax years. Due to the lack of governing authority under Section 1260, our counsel is not able to opine as to whether or how Section 1260 applies to the securities. You should read the section entitled “United States Federal Tax Considerations—Tax Consequences to U.S. Holders—Potential Application of Section 1260 of the Code” in the accompanying product supplement for additional information and consult your tax adviser regarding the potential application of the “constructive ownership” rule.

Subject to the discussions below under “Possible Withholding Under Section 871(m) of the Code” and in “United States Federal Tax Considerations” in the accompanying product supplement, if you are a Non-U.S. Holder (as defined in the accompanying product supplement) of the securities, you generally should not be subject to U.S. federal withholding or income tax in respect of any amount paid to you with respect to the securities, provided that (i) income in respect of the securities is not effectively connected with your conduct of a trade or business in the United States, and (ii) you comply with the applicable certification requirements.

In 2007, the U.S. Treasury Department and the IRS released a notice requesting comments on the U.S. federal income tax treatment of “prepaid forward contracts” and similar instruments. The notice focuses in particular on whether to require holders of these instruments to accrue income over the term of their investment. It also asks for comments on a number of related topics, including the character of income or loss with respect to these instruments; whether short-term instruments should be subject to any such accrual regime; the relevance of factors such as the exchange-traded status of the instruments and the nature of the underlying property to which the instruments are linked; the degree, if any, to which income (including any mandated accruals) realized by non-U.S. investors should be subject to withholding tax; and whether these instruments are or should be subject to the “constructive ownership” regime described above. While the notice requests comments on appropriate transition rules and effective dates, any Treasury regulations or other guidance promulgated after consideration of these issues could materially and adversely affect the tax consequences of an investment in the securities, including the character and timing of income or loss and the degree, if any, to which income realized by non-U.S. persons should be subject to withholding tax, possibly with retroactive effect.

**Possible Withholding Under Section 871(m) of the Code.** As discussed under “United States Federal Tax Considerations—Tax Consequences to Non-U.S. Holders” in the accompanying product supplement, Section 871(m) of the Code and Treasury regulations promulgated thereunder (“Section 871(m)”) generally impose a 30% withholding tax on dividend equivalents paid or deemed paid to Non-U.S. Holders with respect to certain financial instruments linked to U.S. equities (“U.S. Underlying Equities”) or indices that include U.S. Underlying Equities. Section 871(m) generally applies to instruments that substantially replicate the economic performance of one or more U.S. Underlying Equities, as determined based on tests set forth in the applicable Treasury regulations (a “Specified Security”). However, the regulations, as modified by an IRS notice, exempt financial instruments issued in 2018 that do not have a “delta” of one. Based on the terms of the securities and representations provided by us, our counsel is of the opinion that the securities should not be treated as transactions that have a “delta” of one within the meaning of the regulations with respect to any U.S. Underlying Equity and, therefore, should not be Specified Securities subject to withholding tax under Section 871(m).

A determination that the securities are not subject to Section 871(m) is not binding on the IRS, and the IRS may disagree with this treatment. Moreover, Section 871(m) is complex and its application may depend on your particular circumstances. For example, if you enter into other transactions relating to a U.S. Underlying Equity, you could be subject to withholding tax or income tax liability under

#### Supplemental Plan of Distribution

CGMI will pay selected dealers not affiliated with CGMI a fixed selling concession of \$11.75 for each \$1,000 security they sell. For the avoidance of doubt, the fees and selling concessions described in this pricing supplement will not be rebated if the securities are automatically redeemed prior to maturity.

CGMI is an affiliate of ours. Accordingly, this offering will conform with the requirements addressing conflicts of interest when distributing the securities of an affiliate set forth in Rule 5121 of the Financial Industry Regulatory Authority. Client accounts over which Citigroup Inc. or its subsidiaries have investment discretion will not be permitted to purchase the securities, either directly or indirectly, without the prior written consent of the client.

#### Valuation of the Securities

CGMI calculated the estimated value of the securities set forth on the cover page of this pricing supplement based on proprietary pricing models. CGMI’s proprietary pricing models generated an estimated value for the securities by estimating the value of a hypothetical package of financial instruments that would replicate the payout on the securities, which consists of a fixed-income bond (the “bond component”) and one or more derivative instruments underlying the economic terms of the securities (the “derivative component”). CGMI calculated the estimated value of the bond component using a discount rate based on our internal funding rate. CGMI calculated the estimated value of the derivative component based on a proprietary derivative-pricing model, which generated a theoretical price for the instruments that constitute the derivative component based on various inputs, including the factors described under “Summary Risk Factors—The value of the securities prior to maturity will fluctuate based on many unpredictable factors” in this pricing supplement, but not including our or Citigroup Inc.’s creditworthiness. These inputs may be market-observable or may be based on assumptions made by CGMI in its discretionary judgment.

The estimated value of the securities is a function of the terms of the securities and the inputs to CGMI’s proprietary pricing models. As of the date of this preliminary pricing supplement, it is uncertain what the estimated value of the securities will be on the pricing date because certain terms of the securities have not yet been fixed and because it is uncertain what the values of the inputs to CGMI’s proprietary pricing models will be on the pricing date.

For a period of approximately four months following issuance of the securities, the price, if any, at which CGMI would be willing to buy the securities from investors, and the value that will be indicated for the securities on any

brokerage account statements prepared by CGMI or its affiliates (which value CGMI may also publish through one or more financial information vendors), will reflect a temporary upward adjustment from the price or value that would otherwise be determined. This temporary upward adjustment represents a portion of the hedging profit expected to be realized by CGMI or its affiliates over the term of the securities. The amount of this
