**Preliminary Terms**

**Issuer:** Citigroup Global Markets Holdings Inc.  
**Guarantor:** Citigroup Inc.  
**Underlyings:** Apple Inc. and Amazon.com, Inc  
**Pricing date:** August 21, 2018  
**Valuation dates:** November 21, 2018, February 21, 2019, May 21, 2019 and August 21, 2019 (the “final valuation date”)  
**Maturity date:** August 26, 2019  
**Contingent coupon payment dates:** The fifth business day after each valuation date, except that the contingent coupon payment date following the final valuation date will be the maturity date  
2% to 2.25% per quarter (8% to 9% per annum)\*, **only if** the closing value of the worst performing underlying on the immediately preceding valuation date is greater than or equal to its coupon barrier value. **You are not assured of receiving any contingent coupon payments on the securities.**  
**Contingent coupon:** If the closing value of the worst performing underlying on any potential autocall date is greater than or equal to its initial underlying value, the securities will be automatically redeemed on the immediately following contingent coupon payment date for an amount equal to the stated principal amount *plus* the related contingent coupon payment.  
**Automatic early redemption:** Each valuation date beginning in November 2018 and ending in May 2019  
**Potential autocall dates:** For each underlying, 75% of its initial underlying value  
**Coupon barrier value:** For each underlying, 75% of its initial underlying value  
**Final barrier value:** If the securities are not automatically redeemed prior to maturity, you will receive at maturity for each security you then hold:  
**Payment at maturity (if the securities are not earlier automatically redeemed):** If the closing value of the worst performing underlying on the final valuation date is **greater than or equal to** its final barrier value: \$1,000 *plus* the contingent coupon payment due at maturity  
If the closing value of the worst performing underlying on the final valuation date is **less than** its final barrier value: a fixed number of underlying shares of the worst performing underlying on the final valuation date equal to its equity ratio (or, if we elect, the cash value of those shares based on its closing value on the final valuation date)  
**If the securities are not automatically redeemed prior to maturity and the closing value of the worst performing underlying on the final valuation date is less than its final barrier value, you will receive underlying shares (or, in our sole discretion, cash) expected to be worth significantly less than the stated principal amount of your**

**securities, and possibly nothing, at maturity, and you will not receive any contingent coupon payment at maturity.**

## Selected Risk Considerations

You may lose a significant portion or all of your investment. Unlike conventional debt securities, the securities do not provide for the repayment of the stated principal amount at maturity in all circumstances. If the securities are not automatically redeemed prior to maturity, your payment at maturity will depend on the closing value of the worst performing underlying on the final valuation date. If the closing value of the worst performing underlying on the final valuation date is less than its final barrier value, you will not receive the stated principal amount of your securities at maturity and, instead, will receive underlying shares of the worst performing underlying on the final valuation date (or, in our sole discretion, cash based on the value thereof) expected to be worth significantly less than the stated principal amount and may be worth nothing. There is no minimum payment at maturity on the securities, and you may lose up to all of your investment.

You will not receive any contingent coupon on the contingent coupon payment date following any valuation date on which the closing value of the worst performing underlying on that valuation date is less than its coupon barrier value.

The securities are subject to the risks of all of the underlyings and will be negatively affected if any of the underlyings perform poorly, even if the other underlyings perform well.

The return on the securities depends solely on the performance of the worst performing underlying, and you will not benefit in any way from the performance of the better performing underlyings.

The less correlated the underlyings, the more likely it is that any one of the underlyings will perform poorly over the term of the securities. All that is necessary for the securities to perform poorly is for one of the underlyings to perform poorly; the performance of the underlyings that are not the worst performing underlying is not relevant to your return on the securities at maturity or upon an earlier automatic redemption.

The securities may be automatically redeemed prior to maturity, limiting your opportunity to receive contingent coupon payments.

The securities offer downside exposure, but no upside exposure, to the underlyings.

The securities are particularly sensitive to the volatility of the closing values of the underlyings. Whether the contingent coupon will be paid, whether the securities will be automatically redeemed and whether you are repaid your principal at maturity will depend on the closing values of the worst performing underlying solely on the applicable valuation dates.
