Upside participation rate: 150%

Maximum return at maturity: The maximum return at maturity will be determined on the pricing date and will be at least \$212.50 per security (21.25% of the stated principal amount). The payment at maturity per security will not exceed the stated principal amount *plus* the maximum return at maturity.

Buffer amount: 10%

Payment at Maturity: You will receive at maturity for each security you then hold:

If the final underlying value is **greater than or equal to** the initial underlying value:

$\$1,000 +$ the return amount, subject to the maximum return at maturity

If the final underlying value is **less than** the initial underlying value by an amount **less than or equal to** the buffer amount:

\$1,000

If the final underlying value is **less than** the initial underlying value by an amount **greater than** the buffer amount:

$\$1,000 + [\$1,000 \times (\text{the underlying return} + \text{the buffer amount})]$

If the underlying depreciates from the initial underlying value to the final underlying value by more than the buffer amount, you will receive less, and possibly significantly less, than the stated principal amount of your securities at maturity.
