Prior to the disposition of such shares, the shares were owned directly by Capitol Indemnity Corporation (CIC), Capitol Specialty Insurance Company (CSIC), Pacific Compensation Insurance Company (f/k/a Employers Direct Insurance Corporation) (PCIC), Platte River Insurance Company (PRC) and RSUI Indemnity Company (RIC). Alleghany Capital Partners LLC (ACP) acts as an investment manager for each of CIC, CSIC, PCIC, PRC and RIC pursuant to an investment management agreement with each such company, whereby, among other things, ACP has been granted voting power over the shares of common stock of the issued and outstanding stock of CIC and CSIC. Pacific Compensation Corporation (CATA) owns 100% of the issued and outstanding stock of RIC. Alleghany Insurance Holdings LLC (AIHL) owns 100% of the issued and outstanding stock of CATA, PCC, PRC and RSUI Group and 100% of the equity interests in ACP. Alleghany Corporation (Alleghany) owns 100% of the equity interests in AIHL.
