**Item 1.01 Entry Into a Material Definitive Agreement.**

On March 9, 2006, TD AMERITRADE Holding Corporation ( TD AMERITRADE ) granted restricted stock units to executive officers and certain employees of TD AMERITRADE. Each performance restricted stock unit agreement and restricted stock unit agreement required acceptance by May 9, 2006.

On May 8, 2006, TD AMERITRADE extended the date for acceptance of restricted stock units granted under performance restricted stock unit agreements and restricted stock unit agreements by all employees, including executive officers, of TD AMERITRADE for 2 additional weeks. In addition, in connection with the grant of restricted stock units to certain executive officers under performance restricted stock unit agreements, TD AMERITRADE extended the date for execution of employment agreements for 2 additional weeks.
