On July 21, 2003, the Registrant announced the existence of certain collateral shortfalls and other covenant violations at the secured student loan financing facilities of Academic Management Services Corp. (AMS), the Registrant's wholly owned subsidiary. On July 24, 2003, the Registrant announced that it and AMS had obtained waivers with respect to such violations. In that announcement, UICI further advised that it would assess the impact of the events at AMS on the carrying value of UICI's investment in AMS. UICI subsequently engaged the services of an independent valuation advisor to assess the fair value of AMS for purposes of assessing possible goodwill impairment. The Registrant awaits final completion of that valuation in order to complete its final consolidated condensed financial statements for inclusion in its Quarterly Report on Form 10-Q. Registrant will not be able to timely file its Form 10-Q for the second quarter because it will not be able to complete its consolidated financial statements without incurring an unreasonable amount of effort and expense. The registrant expects to be able to file the Form 10-Q within five calendar days, on or before August 19, 2003.
