  - (2) Represents shares of Class A Common Stock withheld by the Issuer to cover tax withholding obligations upon the vesting of PSUs. Pursuant to the terms of the Exchange Agreement dated as of April 9, 2013, a holder may exchange all or a portion of such holder's
  - (3) Common Partnership Units ("New TMM Units") (along with an equal number of shares of the Issuer's Class B Common Stock) at any time for shares of Class A Common Stock of the Issuer on a one-for-one basis.
  - (4) The New TMM Units do not expire and the holder is not required to pay an exercise price in connection with exchanges. The Issuer's Class B Common Stock provides the holder with one vote on all matters submitted to a vote of the Issuer's stockholders but does not

entitle the holder to any of the economic rights associated with shares of the Issuer's Class A Common Stock.
